### **U.S. Proof of Citizenship**

Dear Parents:

### E Pluribus Unum - From Many, One

-- Motto of the United States of America

The Child Citizenship Act of 2000 became effective on February 27, 2001. Beginning on that date, <u>certain, not all,</u> foreign-born children – including adopted children – currently residing in the U.S. acquired citizenship automatically. These children immigrated to the U.S. under an IR-3 visa. Since that time, all children arriving in the U.S. under an IR-3 visa are automatically U.S. citizens the moment they pass through Immigration. If your child arrived in the U.S. under an IR-4 visa (meaning that the single parent or both parents did not physically see the child before the adoption), then U.S. Citizenship <u>was not</u> granted (this also applies to any child who immigrated before February 27, 2001, under an IR-4 visa).



To verify which visa your child was issued, look in your child's foreign passport on the page where Immigration placed its stamp. You will see the visa designation (IR-3 or IR-4) in addition to your child's Alien Registration Number (number beginning with the letter "A".) Parents of children from Guatemala especially should check their child's passport as most children from Guatemala arrived on IR-4 visas. If your child has an IR-4 visa, he or she must be readopted in your home state in order to become a U.S. citizen. Please feel free to contact Legal-Eaze at readoptions@legal-eaze.com to request information on readoption.

On March 1, 2003, the Immigration and Naturalization Service ("INS") began reporting to the U.S. Department of Homeland Security, and its name was changed to the Bureau of Citizenship and Immigration Services ("BCIS"). On November 1, 2003, the name was again officially changed to U.S. Citizenship and Immigration Services ("USCIS") and a new website was launched at <a href="http://www.uscis.gov">http://www.uscis.gov</a>.

Once citizenship is acquired, either by passing through Immigration with an IR-3 visa, or by readopting with an IR-4 visa, you <u>still</u> need to obtain proof of citizenship for your child. For all IR-3 visa children arriving in the U.S. after January 20, 2004, a Certificate of Citizenship ("COC") will automatically be sent to you. You no longer have to apply for a COC for your child. For any child who arrived in the U.S. before January 20, 2004, or any child arriving on an IR-4 visa (even after January 20, 2004), a COC can be obtained by filing <u>Form N-600</u> (if you reside outside the U.S. with your child, you would file Form <u>N-600K</u>). You, as the child's parent (one or both of whom are U.S. citizens), must file Form N-600, Application for Certificate of Citizenship on behalf of your child.

Current as of December 15, 2011, the fee for Form N-600 on behalf of an adopted child is \$550. Print out the first page of instructions from the USCIS website above and send it with your application so USCIS staff will know the current requirements. It specifically states that a COC application for an adopted child is \$550 (not \$600 as for regular applicants).

#### Re: U. S. Proof of Citizenship

To make filing for proof of U.S. Citizenship for your child as easy as possible, we've put together a Citizenship Packet for you to use with our compliments. It is designed to be completed by hand and mailed directly by you to USCIS. The sample letter can be mailed to your local USCIS office (the same office you sent your initial I-600A application to, provided you haven't moved). The USCIS office in New York City is located at 26 Federal Plaza, New York, NY 10278, and can be used for those families living in the following New York counties: Bronx, Kings (Brooklyn), New York City (Manhattan), Queens, Richmond, Nassau, Suffolk, Dutchess, Orange, Putnam, Rockland, Sullivan, Ulster, and Westchester. If you live anywhere outside this area, you can find the address for your local USCIS Field Office at the USCIS Office Locator.

The Constitution gives many rights to citizens and non-citizens living in the U.S. However, there are some rights the Constitution only gives to citizens, like the right to vote and having a U.S. passport and U.S. Government protection and assistance when abroad.

You should be aware that the 1996 Immigration and Naturalization Act included, among other things, a provision requiring automatic deportation of non-citizen immigrants who are convicted of a felony charge. This means that an adopted child, arriving on an IR-4 visa, who fails to get U.S. citizenship by the time he or she is 18 years old, could be sent back to his or her country of origin following any felony conviction; e.g. a second DUI.

Therefore, it is imperative that any child arriving on an IR-4 visa go through the readoption process in his or her state as soon as possible. Your child then becomes a U.S. citizenship upon the issuance of the Certificate of Adoption in your state. Once this is completed, you can then file for the Certificate of Citizenship as proof of citizenship.

### The Oath of Allegiance

I hereby declare, on oath,

that I absolutely and entirely renounce and abjure all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, of whom or which I have heretofore been a subject or citizen;

that I will support and defend the Constitution and the laws of the United States of America against all enemies, foreign and domestic;

that I will bear true faith and allegiance to the same;

that I will bear arms on behalf of the United States when required by the law;

that I will perform noncombatant service in the Armed Forces of the United States when required by the law:

that I will perform work of national importance under civilian direction when required by the law;

that I take this obligation freely, without any mental reservation or purpose of evasion; so help me

A flag that has flown over the U.S. Capitol building in Washington DC may be purchased to commemorate your child's citizenship. Be sure to plan in advance, as your request must be received at least four (4) weeks prior to any commemorative date. Generally you can order it through your Senator's or Congressman's website. We strongly urge all families to apply for and get a Certificate of Citizenship on behalf of their internationally adopted child as soon as possible. It takes only a short time to assemble the documents needed for your child's U.S. citizenship application...and a lifetime to enjoy its privileges!

As an adoptive parent myself, I can easily relate to other families in their adoption journey in addition to offering many years of experience. We do, however, assist adoptive parents with the many forms they need to complete.
